President Harrigan called the regular meeting to order at 9:02 a.m.

NEW BUSINESS

President Harrigan asked if any Board member made any expenditure to influence state legislative or administrative action to which their reply was negative.

COMMITTEE REPORTS

A. Benefits Committee

Commissioner Aliano commented that the Committee is still waiting for action on the Actuarial matter and the report on the ten-year disability cases for everyone with health subsidies and City Administrative Officer regarding adjustments to the Health Subsidy.

B. Governance Committee

Commissioner Diannitto commented that there are two items to be addressed on today's agenda from the Governance Committee, i.e. the Board's approval to begin a search for a consultant to assist in the Board Self Evaluation and the General Manager's Performance Evaluation processes and the approval of the Ethics Policy.

C. Ad Hoc Space Planning Committee

Commissioner Carter stated there is no report at this time.

D. Audit Committee

General Manager Perez reported that the Audit Committee will be scheduled to meet sometime in September subsequent to receiving the City's final audit.

PCA REVIEW OF INTERNATIONAL EQUITY INVESTING

Mr. Allan Emkin, of Pension Consulting Alliance (PCA), and Mr. Tom Lopez, Chief Investment Officer, gave an educational presentation on international investing. Mr. Emkin stated that this is the first step in a multi-step process. Mr. Emkin highlighted aspects of the presentation book and noted that the next step after this presentation would be to come back to the Board with specific recommendations for the international equity portfolio. He stated this would take place within the next 30 days.

Mr. Emkin stated that this institution has a long history of investing outside the United States and over time the portfolio has become more diversified. Mr. Emkin reviewed emerging markets, frontier markets, international equities, benefits of diversification, active management, etc. Mr. Lopez added that this is a snapshot of the Board's complete international equity portfolio and when the term "risk" is used, they are talking about volatility which means how much the returns bounce around. In summary, Mr. Emkin stated that PCA and LAFPP Staff will be coming back to the Board with recommendations involving the benchmark and managers. Mr. Emkin also stated that they will definitely recommend a change in benchmark and, in addition, include Canada in the benchmark.

DOMESTIC EQUITY STRUCTURE REVIEW

Mr. Allan Emkin, PCA, and Mr. Tom Lopez, Chief Investment Officer, reported to the Board on this matter. Mr. Lopez reported that this is a joint recommendation and that there has been an agreement that small cap stocks will represent a smaller part of the domestic equity portfolio – they compromised on a total of 15%. Within this presentation there was a great deal of discussion regarding Enhanced Indexing. If the Board decides to approve and move forward, the City's RFP process might take up to three months, or longer, to complete. It was suggested to reagendaize this matter once the development of a work plan is completed. Again there were many questions from the Commissioners which were answered by Messrs. Emkin and Lopez and it was determined that the Board would require further educational sessions on some of the topics discussed today, including mid cap stocks. Mr. Emkin also informed the Board that a hedge fund that the Board was invested in had failed. However, it was a small investment and the returns for the entire hedge fund portfolio were still positive.

RESOLUTION 08018

Commissioner Aliano moved that the Board authorize Staff to:

- 1) Make all the necessary arrangements and asset shifts to implement the new large cap equity structure when the manager searches are complete; and
- 2) Staff begin the manager searches; and
- 3) Adopt the Russell 3000 Index for the Domestic Equity Portfolio, to replace the current Wilshire 5000 Index; and
- 4) Adjust domestic equity small cap down to 15% from current 20% of the Domestic Equity Portfolio and redeploy to large cap according to new policy weights; and
- 5) Allot equal weightings to domestic equity small cap growth and domestic equity small cap value, revised from current overweight to small cap growth; and
- 6) Replace TCW Growth with Large Cap Growth enhanced index manager; and
- 7) Add Large Cap Core Enhanced Index manager; and
- 8) Rebalance passively managed account back to current policy target of 55% (down from current 63%).

which motion was seconded by Commissioner Diannitto and approved by the following vote: ayes, Commissioners Aliano, Broidy, Carter, Diannitto, Juarez, Keith, Means, Moret and President Harrigan - 9; nays, none.

STATUS OF DOCUMENT MANAGEMENT SYSTEMS IMPLEMENTATION PLAN

Ms. Jan Jordan-Johnson, Jennifer Huang-Leifeste and Laura Guglielmo reported to the Board on this matter. Ms. Jordan-Johnson described the plan, the history behind the plan and the phased approach that Staff is recommending. Once the pilot program is in place, and at the end of Phase 2, Staff believes we will realize the benefits and the efficiencies created, along with the business continuity. At this point in time, there is uncertainty about Phase 3, depending on the benefit to serving our members. Ms. Guglielmo stated that this report is for informational purposes and they will be moving forward and presenting this plan at a Citywide Document Imaging Steering Committee involving the Information Technology Agency, etc. Ultimately, Ms. Guglielmo pointed out, it is the Board's decision on the implementation of the plan. Commissioner Diannitto stated his support for this program, as well as Commissioner Keith. In answer to the question of how long before this plan is implemented, Ms. Jordan-Johnson commented that the basic system should be in place throughout the Department by the end of 2009. Ms. Guglielmo stated that, currently, the Department's Pensions Division is undergoing an extensive payroll system project that needs full Staff support and does not want to burden Staff by removing this full support at this time. Progress on the implementation plan will be brought back to the Board as Staff moves forward on this project. No Board action is necessary at this time.

APPROVAL TO BEGIN SEARCH FOR A CONSULTANT TO ASSIST IN BOARD SELF EVALUATION AND GENERAL MANAGER PERFORMANCE EVALUATION PROCESSES

Ms. Laura Guglielmo reported to the Board on this item. This recommendation comes from the Governance Committee. Commissioner Diannitto wanted to discuss, in particular, the continuance of the LAFPP's contract with the Cortex contract as a consultant. After discussion, it was decided to discontinue the Board Self Evaluation, at this time, due to a consensus of the Board that they did not find value through the Board Self Evaluation process. The Board agreed to hire another firm to develop a method that is effective to evaluate the General Manager. Commissioner Keith had an issue with the General Manager waiting to receive an increase in his merit pay. He felt it lags behind because of the timeline of the evaluation process. After several questions were answered by General Manager Perez and Ms. Guglielmo, the Board agreed to authorize the RFP process to begin to hire another company to assist in the General Manager Evaluation process only and the LAFPP to continue utilizing Cortex in another manner as needed.

RESOLUTION 08019

Commissioner Juarez moved that the Board:

- 1) Authorize the General Manager to release a Request for Proposal to hire a consultant to assist in the General Manager performance evaluation process; and
- 2) Direct staff to continue utilizing Cortex Applied Research's contractual relationship in other areas of assistance to the LAFPP

which motion was seconded by Commissioner Broidy and approved by the following vote: ayes, Commissioners Aliano, Broidy, Carter, Diannitto, Juarez, Keith, Means, Moret and President Harrigan - 9; nays, none.

BOARD REVIEW AND POSSIBLE APPROVAL OF ETHICS POLICY

Ms. Laura Guglielmo made the presentation to the Board on this matter. The only change to the provision is the communication of the Board with consultants. Ms. Guglielmo briefly reviewed the matters at hand that included two new Ethics policies which she described to the Board Members. The other issue is the Commissioners' contact with consultants in specific conversations outside of the Board setting. The current language now outlines the Board's responsibilities and to use their own common sense and good judgment in dealing with consultants. Commissioner Juarez commended Staff for all the work that has been done in dealing with the language for this Ethics Policy. Commissioner Diannitto noted that the Governance Committee could not take a look at everyone's individual concerns but rather had a general purpose approach in dealing with these matters. Board Members and LAFPP concluded that there are a few grey areas and it is difficult to come to any general conclusions but each situation must be dealt with on a case-by-case basis, per Attorney Alan Manning. He also stated that the City Attorney's Office will always make themselves available to Board Members if there is ever any question on a specific contact.




