President von Voigt called the regular meeting to order at 8:32 a.m. All of the above-listed Commissioners were present at the start of the meeting with the exception of Commissioner Moore, who arrived at 8:36 a.m.

Service-connected disability pension is granted at 60% with no foreseeable purpose for review. Motion made by Commissioner Hansell, seconded by Commissioner Aliano and adopted by the following vote: ayes, Commissioners Aliano, Bernardino, Diannitto, Hansell, Moore, Navarro, Pérez, and President von Voigt – 8; nays, none. Fire Captain II Debra J. Brown, Medical Liaison, Los Angeles Fire Department testified regarding the applicant. The applicant was present and represented by his attorney Thomas J. Wicke.

B. ITEMS FOR BOARD ACTION

1. CLOSE-OUT REPORT ON 2010-13 STRATEGIC PLAN AND POSSIBLE BOARD ACTION

Mr. William Raggio, Assistant General Manager, Administrative Operations Division gave an overview of the Strategic Plan process and indicated that it is a key component of the General Manager's annual evaluation. The Governance Committee approved the General Manager Performance Evaluation at the earlier scheduled meeting today. Commissioners will be receiving information from Mr. Allen Goldstein from The Results Group. Mr. Raggio asked that Commissioners please respond to the survey timely. Last year's strategic plan had 8 projects. The next strategic plan will be presented to the Board in the first quarter of the 2012 calendar year and asked the Board for suggestions. Mr. Raggio and General Manager Perez gave a brief history of auditing the Associations, Project 3 to answer Commissioner Bernardino's questions. General Manager Perez stated he will share the results of the audits of the Associations with the Board. Commissioner Hansell suggested that staff develop a rule for the Board to consider with any entity it contracts with to abide by our rules to have full audit rights, and that it be a rule across the board. To address Commissioner Hansell's question regarding the Payroll Conversion, Project 1, Mr. Raggio stated the backup plan is to back up the data to the OnPoint System with the capability to write reports. General Manager Perez stated going forward, he is looking to have this fixed or to look for outside alternatives. He is meeting with Retirement Services of DWP about their system. Mr. Raggio stated the issue of the contract language going forward on software rights is being tracked on the staff assignments of the Monthly Reports. Mr. Raggio addressed cabinet space, Project 2 frequently used documents are being scanned and he discussed backfile conversion in the future. General Manager Perez commented we currently receive electronic copies of many documents via email.

RESOLUTION 12037

Commissioner Diannitto moved that the Board:

1. Receive and file the Close-Out Report on our 2010-13 Strategic Plan; and,

2. Provide the Staff input on current or new strategic initiatives for inclusion in our next (2012-15) Strategic Plan, which was seconded by Commissioner Aliano and approved by the following vote: ayes, Commissioners Aliano, Bernardino, Diannitto, Hansell, Moore, Navarro, Pérez and President von Voigt – 8; nays, none.

2. LEGAL SERVICES MODELS (CF#11-1127) AND POSSIBLE BOARD ACTION

Mr. Raggio gave an overview of the issue. The Board discussed the ability to hire outside counsel and if there is any analysis of the budget impact. General Manager Perez commented on the use of outside counsel and the issue of fiduciary counsel. General Manager Perez also discussed the changing of the cost/billing methodology for City Attorney services. Commissioner Perez requested concrete examples if the recommendation was approved, which General Manager Perez gave where the City Attorney Retirement staff gave advice but was overruled by the City Attorney's Front Office. If the Board wants to move forward, staff will prepare a letter to be signed by the Board President listed with specific information. Mr. Raggio stated this was assigned to the CLA and to the Budget & Finance Committee of the City Council. General Manager Perez informed the Board that it would still utilize the services of the City Attorney. Mr. Manning, Assistant City Attorney stated that they have three clients that they serve: LACERS, DWP and LAFPP and discussed models. Mr. Manning read the City Charter stating that the City Attorney shall be the legal advisor to the City. The Board further discussed the issue.

Commissioner Diannitto moved that the Board:

1. Considered the Council Motions and determined that the Board would like to provide a response to the City Council for its consideration; and,
  2. Instructed staff to prepare a report for the November 3, 2011 Board meeting to provide a response to the City Council, which was seconded by Commissioner Aliano and approved by the following vote: ayes, Commissioners Aliano, Bernardino, Diannitto, Hansell, Moore, Navarro, Pérez and President von Voigt – 8; nays, none.
3. CONSIDERATION OF SCOTT R. SANDERS' REQUEST TO TRANSFER FROM TIER 3 TO TIER 5 AND POSSIBLE BOARD ACTION

Mr. Thomas Puchalski, Senior Management Analyst II, Active Members Services Section presented the report to the Board. Commissioner Navarro raised the issue of allowing transfers due to legal impediments vs. medical. The Board discussed the issues. Commissioner Navarro moved that the Board grant the transfer from Tier 3 to Tier 5, seconded by Commissioner Diannitto. Mr. Manning asked that the matter be continued to allow him time to research if there was an affirmative duty to inform Mr. Sanders of his right to go to the Board to appeal. Commissioners voiced their opinion on the matter. Commissioner Aliano

amended the motion to have the City Attorney do his legal report prior to making a decision and to continue the matter; Mr. Manning stated that he was not allowed to amend the motion. Commissioner Diannitto withdrew his second. Commissioner Aliano moved that the Board direct the City Attorney to research whether the City had an obligation to provide the applicant with information about appeals, seconded by Commissioner Bernardino in which he later withdrew. President von Voigt directed the City Attorney to research if the applicant was informed of his rights to appeal and bring the issue back. General Manager Perez stated he will research what type of information was provided and how it was disseminated to members when the initial period was opened, as requested by Commissioner Moore.

the following vote: ayes, Commissioners Navarro and Pérez – 2; nays, Commissioners Aliano, Bernardino, Diannitto, Moore, and President von Voigt – 5.

*Commissioner Pérez left the board room for the remainder of the meeting, after proposing the 2<sup>nd</sup> motion.*

Commissioner Pérez moved that the Board hire Dimensional Fund Advisors as the Emerging Markets Equity Investment Manager, which was seconded by Commissioner Diannitto and failed by the following vote: ayes, Commissioners Aliano, Diannitto, Moore, and President von Voigt – 4; nays, Commissioners Bernardino and Navarro – 2.

Commissioner Navarro moved that the Board hire The Boston Co. as the Emerging Markets Equity Investment Manager, which was seconded by Commissioner Bernardino and failed by the following vote: ayes, Commissioners Bernardino and Navarro – 2; nays, Commissioners Aliano, Diannitto, Moore, and President von Voigt – 4.

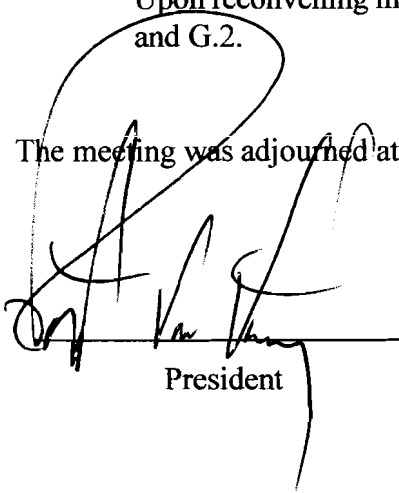
