G. DISABILITY CASE

DISABILITY CLAIM - SURVIVING SPOUSE - TIER 5

As recommended by Staff and concurred in by the applicant, the prior Board action of April 18, 2019, granting a nonservice-connected survivor pension is set aside, and a service-connected survivor pension is granted. Ms. Myo Thedar, Chief Benefits Analyst, Administrative Operations Division presented the report to the Board. The Board congratulated Commissioner Buzzell on his re-election.

Commissioner Navarro moved that the Board declare Kenneth E. General Manager Ciranna discussed the Environmental, Social, and Governance (ESG) language with the Board. Commissioners Babcock and Vega stated that ESG policy will need to be continuously addressed in the future. Commissioner Navarro said our governance

program has been 'way ahead of the curve' nationally. The report was approved as submitted.
